Notification: There will be only thirty-eight booths available and show acceptance will be on a **first come first served basis**. There will be an artist stand-by list as well. Notification of booth spaces is targeted to be sent out on or before October 19, 2009. Booth location will be assigned by show management in order to create the most effective overall display. Booth location requests are welcome but final decisions are made by the show design committee.

Booth Fees: \$225. for 10' x 10' , or a 5' x 20' space, \$275. after September 25, 2009.

Set-Up: Participants will provide their own tables, chairs, set-up equipment, etc. NOTHING can be hung on the tent wall. Overnight security will be provided for Friday and Saturday night. General lighting will be provided, however individual lighting or other electrical needs cannot be accommodated. All booths must be set up and ready to do business by 10am on Friday morning. All materials within an artist's booth MUST fit within the confines of their contracted space (10 X 10 or 5 X 20). No pets are to be brought by exhibitors.

Liability: Artists will handle and set up their own work. The Corrales Society of Artists and The Village of Corrales is not responsible for loss of damage to work. All entrants must sign the attached legal waiver of liability and return with booth fee. Artists are expected to collect all applicable sales taxes.
